West Rusk CCISD will hold an ESSA Private Non-Profit (PNP) outreach and general information meeting at West Rusk CCISD on Friday, May 3, 2024, at time 9:00 am to discuss:

- Title I, Part A, Improving Basic Programs (must have qualified students)
- Title I, Part C, Migrant (must have qualified students)
- Title II, Part A, Supporting Effective Instruction
- Title III, Part A, English Learners (must have qualified students)
- Title III, Immigrant Students (must have qualified students)
- Title IV, Part A Student Support & Academic Enrichment

If your facility is a private nonprofit school, you could be eligible for ESSA programs listed above. If participating in receipt of services, the Private Non-Profit school will be required to:

- Provide documentation verifying the enrollment of students in the PNP residing in the ISD boundaries
- Provide a needs assessment identifying areas of needs for the students attending the PNP residing within the ISD boundaries
- Provide student data to determine eligibility

Please note, if your school chooses to participate in receiving equitable services through Title funds from the Federal Government, your students will be required to participate in assessments throughout the school year, to provide data on progress. This data will be reported to the Federal Government via TEA, Grants Administration.

- After the consultation, LEA establishes the assessments it will use to measure the effectiveness against the agreed-upon standards.
- May use the State assessment or another assessment that is aligned with the agreed-upon standards.
- All participants are assessed at least annually, including children receiving nonacademic services.
